


We also came across another stolen vehicle in Bassetlaw and following a short pursuit landed in a Clarborough garage where other stolen vehicles were found and what looked like a 'chop shop' used to break vehicles apart for their parts to sell on. On searching for the driver of the vehicle a cannabis grow was discovered in one of the buildings with approx. 200 plants. It was clear we had come across an organised criminal operation.

This month has been extremely busy for us in Bassetlaw. You will all be aware there has been a murder

investigation going on and four people have now been charged in relation to it. I would like to thank my officers in the Reacher team for apprehending the murder suspects within a few hours of the report coming in and all the officers who've been guarding scenes over the last week. It has been extremely resource intensive but

Carlton in Lindrick has been a concern recently with ASB in the community. As a result, our officers have been working with the ASB team from BDC and housing to put a plan of action in place. PC Cupitt our officer for Carlton in Lindrick is leading on this piece of work along with PCSO's Jaime Shaw and Cathy Parker. Our off-road bike team have also been to the area to tackle the issues being reported so we are collectively making ground.

This month our team went out and Within one hour of the report of a body being found, officers identified a vehicle which was believed to contain two murder suspects. Officers used ANPR to co-ordinate staff from OS before stinging the vehicle in Retford and arresting both suspects for Murder. The pair have since been charged and remanded into prison.

Also this month our work included locating and arresting a male, who tested positive for cocaine on a Drugs Wipe. While two staff were dealing with this, the other two officers located and arrested a male suspected of dealing class A and B drugs in the town centre. The male was arrested and a quantity of drugs were recovered. We executed a Misuse of Drugs Act warrant at an address in Sandy Lane. A quantity of Amphetamines were recovered.

Officers joined the East Bassetlaw NPT and Food Crime Unit from the Food Standards Agency to execute a warrant at West Stockwith. The warrant concerned large scale fraud.

Officers assisted CID teams by arresting a suspect of a GBH and locating a knife that was used in the offence. Officers assisted response and colleagues from Firearms in the arrest of a male suspected of possession of a firearm with intent to cause fear of violence.

The North Team

July was another busy month for Worksop NPT North. As well as all the normal day to day work the team undertakes, July saw ASB week come and go whilst the recent heatwave was on. The team attended a number of multi-agency surgeries to understand from a variety of agencies what matters to the community and how best we can support them, with the overall aim to reduce incidents of ASB. As well as this, where possible patrols were increased, which included the off road bike team helping step up patrols in the Carlton In Lindrick area.

Carlton in Lindrick has been an area of focus for us over the last month where we have been problem solving with our ASB partners from the council and the local housing team. The issues in Carlton are more complex than being able to enforce our way out of them.

As the month has tailed off, demand has not let up and the team have been utilised to assist with some serious incidents that occurred across Worksop. These include covering scenes for the murder enquiry.

August is looking likely to be another busy month as the schools break up for summer holidays. The team will be continuing to concentrate their efforts on limiting incidents of ASB that this may bring in collaboration with our partners. We welcome any local community activities which keep young people engaged whilst they are off over the summer.

The South Team

We were involved with the ASB Awareness week which ran from 18-24 July 2022. We focused on tackling Anti-social Behaviour within Worksop and surrounding villages.

Tuesday 19th July and Wednesday 20th July saw joint patrols through Worksop Town Centre with the Council ASB team to reinforce the conditions of the new PSPO (Public Spaces Protection Order) which is now in place in the Town Centre. There is new signage going up in the town centre to give details of the conditions and how to report any breaches.

On Thursday 21st July 2 males were arrested for affray in Worksop Town centre after reports from the public that they were fighting in the street. One of these males were also arrested for further assaults and possession of drugs. Both males were interviewed and bailed with conditions pending charging advice from the Crown Prosecution Service.

On Thursday 21st July and Friday 22nd July evenings Officers were patrolling the Manton and Carlton In Lindrick areas in relation to the ongoing issues with off road motor bikes causing anti-social behaviour in the area which have been reported to us over the past few weeks.

Other results this month include,

A female was stopped driving a vehicle when she drove on the wrong side of the road toward a Police Vehicle and then onto the kerb to avoid a collision. Female was arrested for driving whilst under the influence of drugs and careless driving.

During a joint department operation conducted earlier this month a male was pursued in a vehicle that failed to stop and was detained after a chase. He was arrested for failing to stop for Police, Theft of motor vehicle and Possession with intent to supply class A drugs.

A male in the town centre was issued with a CBO which took effect of 29th July which prohibits him from being in the Town centre. This male has been in the town centre that same day and was swiftly arrested for the breach. He has been charged with the breach of his CBO.



Team updates: East Bassetlaw

July has been a very busy month for the team.

Pc Mitchell has been working with the Eaton parish council after CCTV captured several issues on hot days near to the bridge.

With large numbers gathering on the bridge, youths have been seen to lie down in the roads, causing obvious road safety issues. Also, high powered vehicles have been launching off the bridge at high speed continuing through the village in a dangerous manner.

As a result of these issues, we obtained a dispersal in the area which we could police especially during hot weather which is when most of the issues occur. We give notice of the dispersal on our social media which certainly deterred those who have previously been involved and we had not further incidents.

We will continue to use the ASB dispersal legislation and if appropriate look to use this elsewhere should other similar issues arise.

Together with the Bassetlaw District Council we have now amended our Public Space Protection Order map (PSPO). We have now extended our map in Retford to include the new Lidl, Asda and KFC off London Road. This will allow the Police to combat any ASB that may occur within this newly built commercial area.

Two prolific shop theft offenders were also detained this month. One male was charged with 7 thefts and received a suspended sentence. We are actively policing this male due to the impact he is having on the local businesses. A further male, also responsible for several shop thefts was remanded into custody and received a 6 week prison sentence.

My team, together with Operation Reacher officers from Bassetlaw and Newark & Sherwood were involved in a search of a large commercial premises North of the County. We accompanied the National Crime Food Agency who took primacy of the investigation which remains ongoing.

During July, the team have been involved in two significant incidents that have demanded extra resources, such as the house fire at Treswell. The team and I were first on scene at the large house fire and together with the fire service were involved in community engagement due to the impact this incident had on the local community.

The team have also been involved for several days at an incident within Bassetlaw and the enquiry is continuing at this time.
