

# Clarborough Village Hall wifi services Agreement

## Users signing this agreement overleaf agree to the following:

This agreement is for the use of a **single device** (PC, laptop, iPad, etc) within Clarborough Village Hall to access Clarborough & District Community Association's village hall wi-fi service. When using the WiFi service you agree at all times to be bound by the following provisions: Not to use the WiFi service for any for the following purposes:

- Accessing any personal online accounts such as email to engage in personal communication except to engage in arranged agreed online meeting/event hosted by Zoom, Microsoft Teams, etc.
- Engaging in any form of financial transaction such as purchasing or ordering any items or services.
- Accessing and viewing any illegal material.
- Disseminating any unlawful, harassing, libellous, abusive, threatening, harmful, vulgar, obscene, or otherwise objectionable material or otherwise breaching any laws.
- Transmitting material that constitutes a criminal offence or encourages conduct that constitutes a criminal offence, results in civil liability, or otherwise breaches any applicable laws, regulations, or code of practice.
- Interfering with any other persons use or enjoyment of the WiFi service
- Making, transmitting, or storing electronic copies of material protected by copyright without permission of the owner.

**You are obliged to keep any username, password, or any other information which forms part of the WiFi service security procedure confidential and not to disclose it to any third party.**

We have the right to suspend or terminate our Wi-Fi service immediately in the event that there is any breach of any of the provisions of these Standard Conditions including without limitation:

- If you use any equipment which is defective or illegal.
- If you cause any technical or other problems to our WiFi service.
- If, in our opinion, you are involved in fraudulent or unauthorised use of our WiFi service.
- If you resell access to our WiFi service; or
- If you use our WiFi service in contravention of the terms of these Standard Conditions.

Although we aim to offer the best WiFi service possible, we make no promise that the WiFi service will meet your requirements. We cannot guarantee that our WiFi service will be fault-free or accessible at all times.

It is your responsibility to ensure that any WiFi enabled device used by you is compatible with our WiFi service and is switched on.

The availability and performance of our WiFi service is subject to all memory, storage, and any other limitations in your device. Our WiFi service is only available to your device when it is within the main hall.

We are not responsible for data, messages, or pages that you may lose or that become misdirected because of the interruptions or performance issues with our WiFi service or wireless communications networks generally. We may impose usage, or service limits, suspend service, or block certain kinds of usage in our sole discretion, to protect other users of our WiFi service.

Network speed is no indication of the speed at which your WiFi enabled device or our WiFi service sends or receives data. Actual network speed will vary based on configuration, compression, and network congestion.

- We may make a small charge for accessing our wi-fi services which will be discussed with users prior to providing this service.
- We may collect and store personal data through your use of our WiFi service.
- We may process all information about you which is provided in relation to our WiFi service in accordance with your legal rights under the Data Protection Act 2018 and solely for
- the purposes of offering the WiFi service.

By using our WiFi service, you agree to the terms of this clause. Our WiFi service is owned/funded by Clarborough & District Community Association (CDCA). If you would like more information or object to these terms, you should speak to CDCA.
